| Obim ovlaštenja/ Scope of authorization | Ovlaštenje se daje u odnosu na ugovore u osiguranju, zaključene, odnosno obnovljene nakon dana potpisa ovog ovlaštenja, u kojima je Klijent Ugovarač osiguranja. <i>The authorization (BORL) is given in relation to insurance contracts, concluded or renewed after the date of signature of this authorization(BORL), in which the Client is the Policyholder.</i> |
| Period trajanja ovlaštenja/ Period of authorization | Ovlaštenje se daje na neodređen period, uz mogućnost otkazivanja ovlaštenja u bilo kojem trenutku, uz otkazni rok od 90 dana. Otkaz ovlaštenja se vrši putem pisane obavještenja. <i>The authorization(BORL) is granted for an indefinite period, with the possibility of canceling the authorization at any time, with a notice period of 90 days. Termination of authorization(BORL) is done by means of a written notification.</i> |
| Naplata usluge/ Service charge | Posrednik nema pravo od klijenta zahtijevati plaćanje provizije ili bilo kakvu drugu naplatu, osim ako to nije izričito pismeno ugovoren. <i>Broker has no right to demand the payment of a commission or any other payment from the client, unless it is expressly agreed in writing.</i> |
